



Cereals usage by Millers, Brewers and Maltsters UK - February 2013

This statistical release contains information on the use of cereal grain, flour production and stocks of cereal by these cereal processors on a monthly and crop year basis (of which Oatmeal Millers is now on a quarterly basis). The flour millers data includes use of wheat for starch and bioethanol production.

The results for the usage of wheat, barley and brewers and maltsters are released monthly and will next be updated at 9:30am on 09 May 2013.

The Oatmillers survey will be updated quarterly, the next update will be at 09:30 on 09th May 2013.

Key Points of Wheat & Barley

In February 2013 compared with February 2012:

Wheat Usage:

- The total amount of wheat milled was 520 thousand tonnes, up 15%.
- The total amount of home grown wheat milled was 356 thousand tonnes, down 12%.
- The total amount of imported wheat milled was 164 thousand tonnes, up 233%.
- Brewers, maltsters and distillers total wheat usage was 64 thousand tonnes, up 20%.

Barley Usage:

- Brewers, maltsters and distillers total barley usage was 146 thousand tonnes, down 2%.

Key Points of Oats

In October to December 2012 compared with October to December 2011:

Oats Usage:

- The total amount of oats milled was 124 thousand tonnes, up 3%.

Revisions

Oats: Figures for total milled and closing stocks incorporate DEFRA estimates with the survey data and are subject to future revisions. There are estimates included representing approximately 20% of the overall production and oats milled figures.

Flour: A small amount of estimation this month, which will be subject to future revisions.

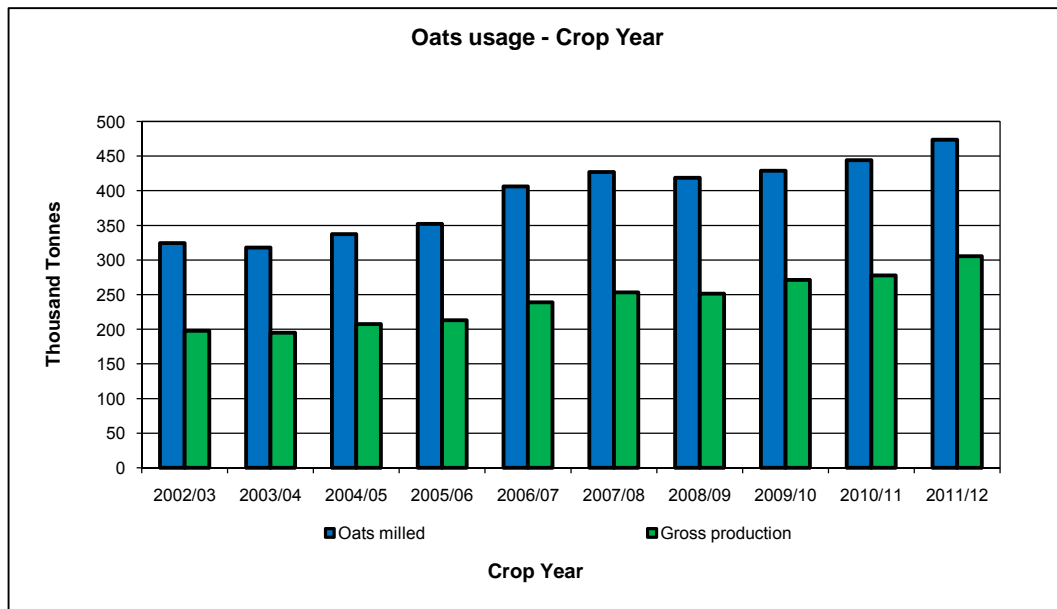

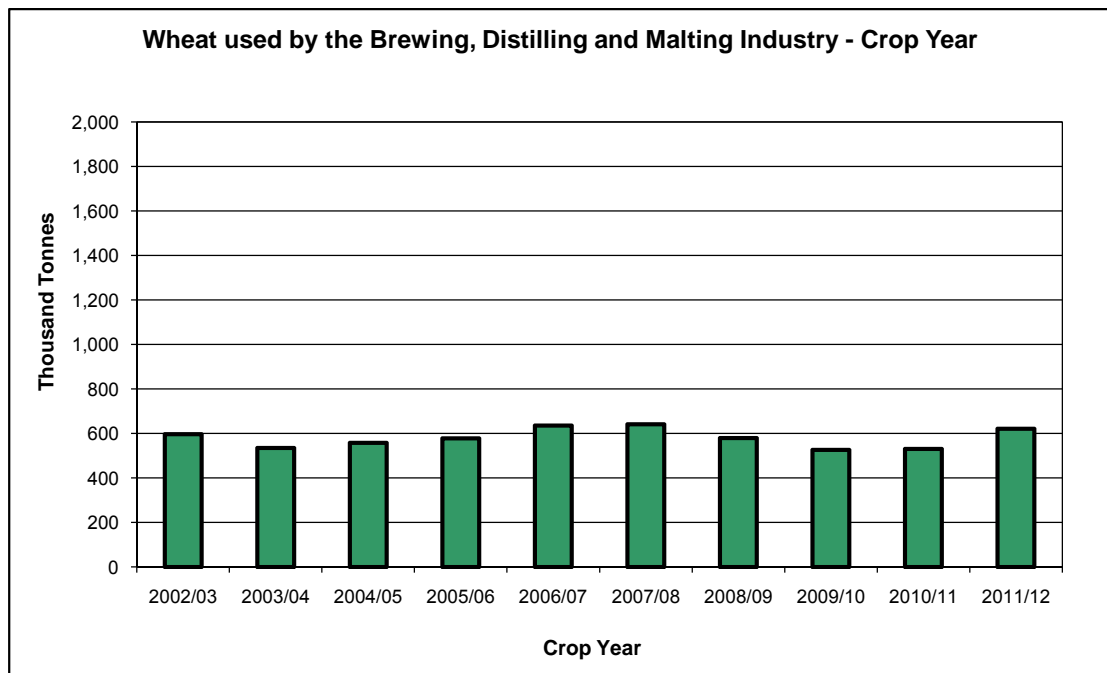
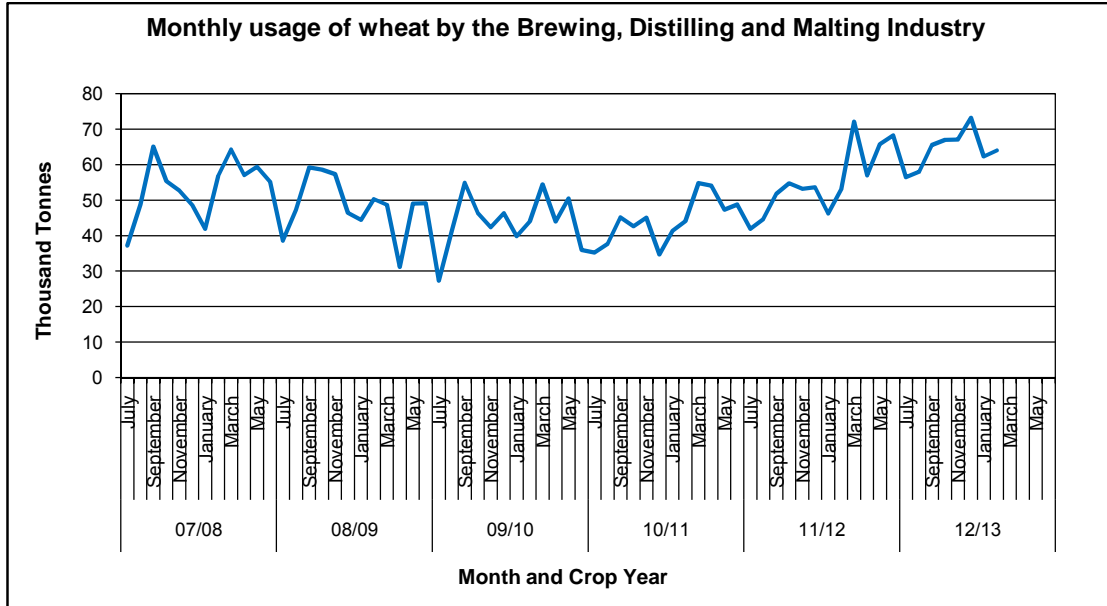

The difference between oats milled and gross production is accounted for by losses in the production process and by-products.



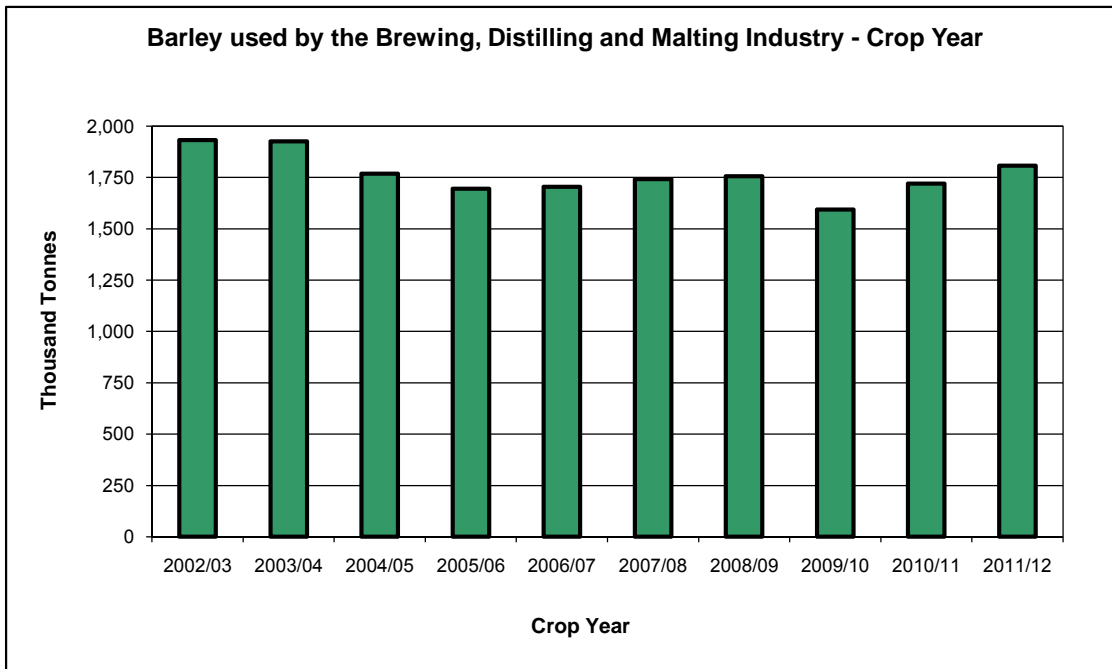
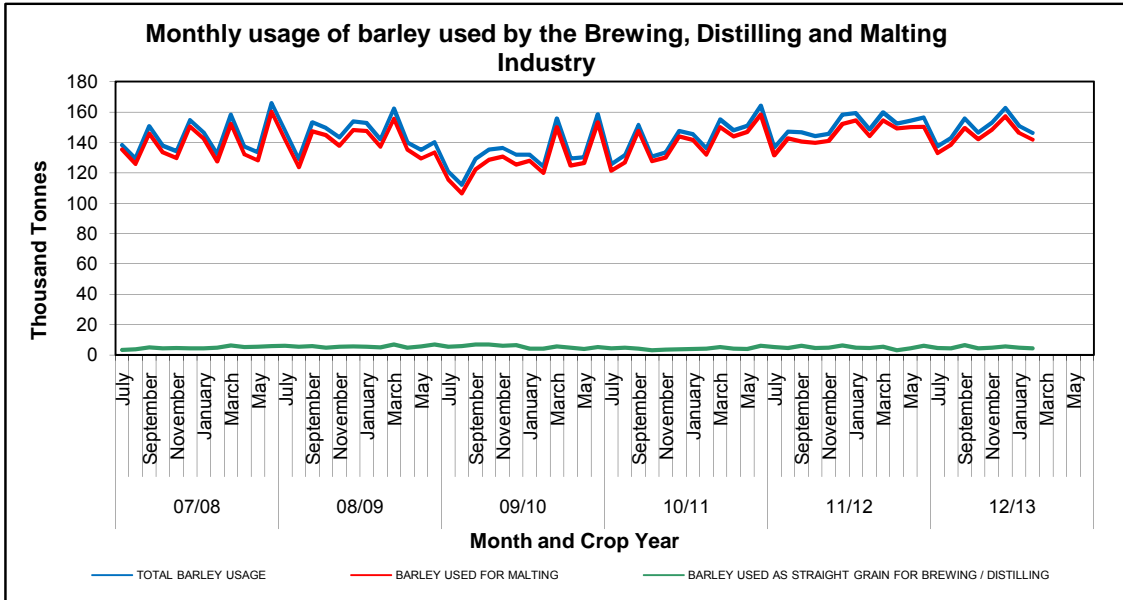
WHEAT USAGE

Methodologies, Notes and Revisions Policy

User Statement

The information in this notice is used by the UK government and the EU as evidence for assessing market conditions and evaluating agricultural policy. Statistical Release History

This newly combined statistical release (previously published as separate statistical releases titled Wheat Milled and Flour Production, Cereal Usage by Brewers, Maltsters and Distillers and the Oatmeal Millers) shows usage and stocks statistics on a monthly basis for wheat, barley and quarterly for oats. Survey Methodologies

These compulsory surveys, the Wheat Milled and Flour Production, the Cereal Usage by the Brewers, Maltsters and Distillers and the Oatmeal Millers collect data under the Statistics of Trade Act 1947. The data reported in this statistical release are from survey returns of all of the major users of wheat, barley and oats in the UK.

Companies for the Wheat Milled and Flour Production and the Cereal Usage by the Brewers, Maltsters and Distillers are contacted monthly or annually and their usage, stock and sales statistics are recorded. Most companies are sampled monthly, but smaller companies are sampled annually. Estimates for the smaller companies that are not part of the monthly survey are made and included in the published figures. This reduces the chance of a large increase in the crop-year to date totals when the actual annual returns are incorporated into the data. For both the Brewers, Maltsters and Distillers and the Wheat Milled and Flour Production Surveys the smaller companies account for less than 5% of the total production.

Companies for the Oatmeal Millers survey are contacted quarterly and published quarterly. All known companies are sampled quarterly.

Totals for the current crop year to date are shown (July to June) as well as for the most recent month.

Accuracy and Reliability of the Results

The accuracy of the survey results is very high because a census is carried out of all companies and the typical response rate is 100% per year. Occasionally data is not published when it fails strict disclosure and dominance checks. This ensures that statistics cannot be traced back to a particular company. For the Wheat Milled and Flour Production Survey, since October 1999, self raising flour has only been used by a minority of companies so is no longer displayed. For the Cereals Usage by the Brewers, Maltsters and Distillers, maize has only been used by a small number of companies and therefore has not been published. The data are subject to a variety of validation checks which identify any inconsistencies in the data. These would then be verified with the relevant survey respondent and any figures would be amended prior to publication.

Revisions Policy

Figures in this notice are provisional and subject to revision. We will provide information about any revisions we make to previously published information in this statistics notice, and the associated datasets. Revisions could occur for various reasons, including:

- a. if we have not received survey data from respondents we make an estimate based on their previous returns. These estimates will be replaced with actual survey data when it is received.
- b. when survey respondents occasionally supply amended figures for previous periods.
- c. revising previous estimated data for smaller companies with actual survey data on an annual basis.
